"上海论坛"是由复旦大学和韩国高等教育财团主办,复旦发展研究院承办的国际论坛,发起于2005年。论坛总部设在中国上海,是非盈利的民间学术组织。论坛最具影响力的活动是每年5月在复旦大学举办的论坛年会。在全球经济一体化进程加快的背景下,论坛以"关注亚洲、聚焦热点、荟萃精英、推进互动、增强合作、谋求共识"为宗旨,通过年会搭建"学界、政界、商界"三方交流互动的平台,在集思广益的基础上为亚洲经济、政治、社会和文化的全面进步提出发展建议和决策参考。

"上海论坛"依托上海、立足复旦,在专家委员会和组织委员会的共同运作下,通过全球网络联系和汇聚社会精英。年会期间,来自全球学、政、商界精英、领袖通过形式多样的分论坛研讨会、圆桌会议等发表见解,开展对话与交锋,就亚洲经济和国际局势所面临的重大问题进行广泛、深入的研讨,探求共识。多位中外政要、中外著名大学校长、海内外著名学者包括诺贝尔经济学奖获得者、中外商界精英曾受邀出席论坛年会并发表大会主旨演讲。论坛邀请世界知名企业和机构领导人等精英人士担任国际顾问团成员。论坛与耶鲁大学、芝加哥大学、圣路易斯华盛顿大学、乔治敦大学、香港中文大学、早稻田大学、伦敦政治经济学院、杜伦大学、东英吉利大学、美国亚洲协会、德国弗里德里希•艾伯特基金会、英国丁铎尔气候变化研究中心等机构以及韩国 SK 集团等跨国企业建立了密切的战略合作关系。

"上海论坛"在探索与发展中已成功举办了八届年会,现已成为中国最重要的国际性学术论坛之一。论坛每年发布"上海论坛 共识",其学术及社会影响力正在逐年提升。在国际合作的基础上,"上海论坛"不断充实内涵,凝聚思想精髓,为亚洲经济、 政治、社会和文化的全面进步建言献策,成为亚洲国家交流合作的桥梁和纽带,正在步入探讨亚洲发展与全球热点问题的国际 精英论坛之列。

> About Shanghai Forum

Shanghai Forum, launched in 2005, is an international forum hosted by Fudan University and Korea Foundation for Advanced Studies, and organized by Fudan Development Institute. With its headquarter in Shanghai, the Forum is a non-governmental and non-profit organization. The highlight of Shanghai Forum is the annual symposium in each May at Fudan University. Under the background of economic globalization, the Forum takes its mission as "Concentrating on Asia, Focusing on Hot Issues, Congregating Elites, Promoting Interactions, Enhancing Cooperation and Seeking Consensus". It endeavors to build a platform for communication among academic, political and commercial circles by inviting leaders and elites of all fields to co-operation and dialogue, so as to provide perspectives and advices for Asia's overall economic, political, social and cultural progress.

Rooted in Shanghai and based on Fudan University, "Shanghai Forum" gathers global elites with the collective effort of Academic Steering Committee and Organizing Committee. During the annual conference, the elites and leaders from different academic, political and business circles express their opinions, conduct dialogues and initiate brainstorms in various forms. They discuss comprehensively and profoundly on major issues in Asian economy and international situation to seek a consensus.

Many Chinese and foreign senior dignitaries have attended the Forum and delivered keynote speeches, chaired by presidents from prestigious universities both at home and abroad. World-class scholars, including Nobel Prize laureates and numerous business elites have delivered keynote speeches as special guests. After eight years of successful operation, "Shanghai Forum" has become one of the most important academic forums in China. The "Shanghai Forum Consensus" issued on annual conference has exerted an increasing academic and social impact. On the basis of international cooperation, "Shanghai Forum" will continue to enrich her scale and scope in an effort to provide consultancy for Asian economic, political, social and cultural progress.
